1207. FORMAL OBLIGATION TO CONSTANZE MOZART BY KONSTANTIN PHILIPP WILHELM, BARON JACOBI, VIENNA, AND CONSTANZE MOZART'S CESSION TO JOHANN ANTON ANDRÉ, OFFENBACH  $^2$ 

[Vienna, 4<sup>th</sup> March, 1792]

The undersigned states hereby his obligation, legally binding and in all due form, to Frau Konstantia, widow Mozart, née Wéber, to return the following original scores entrusted to him to her hands after making copies: *La Betulia liberata*, an *Oratorio*, and two *Lytanies de Corpore Christi*. [5] Enacted Vienna, 4<sup>th</sup> March, 1792.

The King of Prussia had given him on 17<sup>th</sup> February, 1792, a list of eight works which he should attempt to buy from Mozart's widow. Recognisable here are three of these eight: *La Betulia liberata* KV 118 (74c), and the two *Litaniae de venerabili altaris sacramento* KV 125 and KV 243. The *Oratorio* is not clearly identifiable and may have suffered the fate surmised by Johann Anton André (BD VI, p. 431). The copyist's note concerning the *Requiem* suggests that Süssmayr's completion work was already far advanced by this date. Johann Anton André finally recovered the scores named in the obligation, after great efforts, from the Royal Library in Berlin in 1831.
